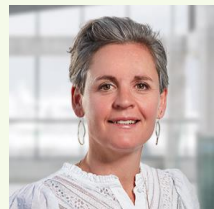

HEAR MARTIN TALK ABOUT HOW THEY ENSURE THAT THEIR INVESTMENTS CONTRIBUTE TO A BETTER WORLD IN RELATION TO ENVIRONMENTAL, SOCIAL AND OTHER SUSTAINABILITY PARAMETERS.

SHE WILL GIVE US AN INSIGHT INTO THE SPECIFIC CURRENT AND FUTURE REPORTING REQUIREMENTS AS WELL AS HOW WE CAN MONITOR AND IMPROVE ON THE MANY ESG METRICS

WHAT PREFERENCES AND DEMANDS WILL THE OUTSIDE WORLD PLACE ON THE FOOD OF THE FUTURE, AND WHAT WOULD MAKE SENSE AND BE SAFE FOR US AS PRODUCERS PAY ATTENTION TO, AND IN AND INVEST IN? ALREADY NOW, THERE ARE A NUMBER OF BUYERS OF PRIMARY AGRICULTURAL PRODUCTS WHO PLACE DEMANDS ON THE METHOD OF PRODUCTION IN RELATION TO SUSTAINABILITY. DFA WINTER CONFERENCE

IN RECENT YEARS, TRINE VIG HAS HAD FULL FOCUS ON THE EU AND THE REVISION OF THE RULES FOR ANIMAL WELFARE AND TRANSPORT OF ANIMALS, WHICH THE CURRENT EUROPEAN COMMISSION LAUNCHED BACK IN 2020, AS PART OF THE "FARM TO FORK" STRATEGY. TRINE WILL GIVE A QUALIFIED IDEA OF WHAT RULES WE AS ANIMAL PRODUCERS CAN EXPECT IN THE COMING YEARS WITHIN THE EUROPEAN COMMUNITIES, AND HOW IT WILL AFFECT OUR ABILITY TO COMPETE WITH THE REST OF THE WORLD'S ANIMAL PRODUCTS.

GET A HANDS-ON INSIGHT INTO HOW THE EUROPEAN PARLIAMENT WORKS WHEN ASGER TALKS ABOUT THE DAILY WORK OF DEFENDING AGRICULTURAL INTERESTS IN THE LARGER COMMUNITY. WHICH TOPICS ARE HIGHEST ON THE AGENDA WHEN IT COMES TO AGRICULTURE AND FOOD, AND WHERE ARE THE HOT SPOTS AND DISAGREEMENTS IN DIFFERENT COUNTRIES' POSITIONS ON HOW THE SECTOR SHOULD BE REGULATED AND DEVELOPED.

PANEL DISCUSSION ON AGRICULTURE'S OPPORTUNITIES TO BECOME CLIMATE HEROES INSTEAD OF CLIMATE SINNERS. WHAT DIRECTION SHOULD WE GO IN ORDER TO GET IT RIGHT, AND HOW DO WE COMMUNICATE OUR ACTIONS TO POLITICIANS AND CONSUMERS?

HOW WILL THE WORLD DEVELOP GEOPOLITICALLY IN THE SHORT AND MEDIUM TERM, GIVEN THE WAR IN UKRAINE, THE WAR IN GAZA, TENSIONS BETWEEN THE US AND CHINA AND THE INCREASING POLARIZATION IN MUCH OF THE POLITICAL SPECTRUM WORLDWIDE?

(Peter Viggo Jakobsen from the Royal Danish Defence College is one of the most cited researchers in Denmark at the moment, not least because of his analytical but also very straightforward approach to various conflicts and wars in the world. Peter will analyze the current war situation, and on the basis of that give his take on the consequences for the political, economic and security situation in the world.)
